

# COLOR VISIONARY

## TERMS & CONDITIONS



The Northern Europe TrendVision Award (NTVA) is an online photographic competition run by Wella Company Northern Europe (hereinafter referred to, together with its affiliates and parent company as "Wella Company").

NTVA is a competition with several categories:

- Northern Europe Color Visionary of the year (by Wella Professionals)
- Northern Europe Craft Visionary of the year (by Wella Professionals)
- Northern Europe Editorial Look of the year (by Sebastian)

This document presents the terms and conditions of Color Visionary of the year category in Northern Europe.

## 1. ABOUT THE HAIRDRESSER

- 1.1 The Northern Europe Color Visionary of the year category is open to all qualified hairdressers/colorists working as a hairdresser (no age limit) in Northern Europe only.
- 1.2 No families nor close family members (brothers, sisters, parents, children, husband or live-in partners) of employees working for Wella, will be allowed to enter the competition.
- 1.3 Only the competitor, whose name is on the entry form, can receive the NTVA Color Visionary of the year prize (see article 4).
- 1.4 The competitor must be a qualified hairdresser.
- 1.5 The competitor and model must be above 18 years old.
- 1.6 The competitors can submit as many entries as they like across all categories, but each entry must be a different image/look with a clear difference in the hair color, cut or style. If a competitor is selected in several categories as finalist, he/she will be contacted to choose the category he/she/they wants to compete in.

## 2. ABOUT THE COMPETITION

- 2.1 The NTVA is an online photographic competition where competitors will post a photograph of the finished look on social media made with Wella Professionals products only.
- 2.2 By submitting pictures to us in connection with the TrendVision Awards competition, you "the competitor" represent and warrant to Wella Company that all photographic images submitted in connection with the TrendVision Award were done with Wella Professionals products. Upon Wella Company's request, each competitor must be prepared to provide (within five calendar days of receipt of Wella Company's request) the list of Wella Professionals products used. Failure to provide such information or failure to prove the looks were done with Wella Professionals products upon request may result in disqualification at any time during the competition and selection of an alternate finalist or winner.
- 2.3 A panel of judges will judge all pictures and will choose the final winners.

A successful look should show:

- 2.3.1 A color that is highlighting the authentic beauty of your model
  - 2.3.2 A color and styling that complement each other while creating a beautiful, wearable and salon-relevant total look
  - 2.3.3 An inspiration that has been taken from many sources
  - 2.3.4 A color work that reflects the professional expertise and ability of the colorist to create a tailor-made result
  - 2.3.5 Shiny hair in excellent condition with the highest professional finish
  - 2.3.6 Makeup and styling that complement the overall look, working in synergy with the hairstyle showing the highest level of craftsmanship
- 2.4 Hair Up / Up do's are prohibited in this category as is the use of fake hair / hairpieces / extensions, etc.

### 3. ABOUT THE ENTRY PHASE

- 3.1 Complete a look and upload one photo of the completed look on your Instagram feed, using hashtag #COLORVISIONARY24\_NE, #NE\_NTVA24 & tag @wellanordic & @wellaprobnl into the caption (not in the comments). Make sure to include stylist name, salon, city and country in the caption.
- 3.2 By submitting pictures to us in connection with the TrendVision Awards competition you, "the competitor" represent and warrant to Wella Company that all photographic images submitted in connection with the TrendVision Award, constitute original copyrighted works of the competitor and that the competitor is free to grant and does hereby grant Wella Company a non-exclusive, royalty-free, fully paid, perpetual, right and license to reproduce, distribute, display and create derivative works of the entry in connection with the competition and promotion of the competition, in any media now or hereafter known. If the photograph contains any materials or elements that are not owned by the competitor and/or which are subject to the rights of third parties and/or if any persons appear in the photograph, the competitor is responsible for obtaining, prior to submission of the photograph, any and all releases and consents necessary to permit the exhibition and use of the photograph in the manner set forth in these official terms and condition without any compensation. If any person appearing in any photograph is under the age of the majority in their country of residence, the signature of a parent or legal guardian is required on each release. The competitor shall indemnify and hold Wella Company harmless from any losses incurred by the indemnified parties due to a breach of the representations and warranties made in this agreement. Upon Wella Company's request, each competitor must be prepared to provide (within five calendar days of receipt of Wella Company's request) a signed release from all persons who appear in the photograph submitted and/or from the owner of any materials that appears in the photograph, authorizing Wella Company to reproduce, distribute, display and create derivative works of the entry in connection with the competition and promotion of the competition, in any media now or hereafter known. Failure to provide such release upon request may result in disqualification at any time during the competition and selection of an alternate finalist or winner.
- 3.3 Each contestant who wishes to enter the competition will be asked to write in the Instagram comment section "By posting this photo, I agree and assign my intellectual property rights to Wella Company".
- 3.4 Entries will be accepted using an existing photo if it has not been submitted to NTVA previously. The photo should have been taken no more than 12 months prior to submission.
- 3.5 Photos taken on a phone are totally acceptable and care must be taken to submit the best possible quality of photograph. All photographs either professionally shot or taken on a mobile phone will be judged equally.
- 3.6 Closing date for entries is 31<sup>st</sup> of October 2024. Entries received after this date cannot be accepted.
- 3.7 Pictures will be judged by Wella Professionals panel of artists ("Judges") on:
  - 3.7.1 40% of the total vote will come from color choice and suitability to the models features, skin and eye color
  - 3.7.2 30% of the total vote will come from the quality of the execution and overall beauty of the color, hair quality, condition and shine
  - 3.7.3 30% of the total vote will come from the overall finished look color, cut, styling

- 4.3 The NTVA Color Visionary of the year Silver winner will receive:

  - 4.3.2 A trophy
- 4.4 The NTVA Color Visionary of the year Gold winner will receive:
  - 4.4.1 An exclusive invite to the 2025 Destination event
  - 4.4.2 A 1000 Euro Gift Card to spend on seminars at [www.education.wella.com](http://www.education.wella.com) and/or products on [www.wellastore.com](http://www.wellastore.com)
  - 4.4.3 A trophy

### 5. ABOUT ITVA 24' COMPETITION

- 5.1 The NTVA Color Visionary of the year Gold winner will compete for the International TrendVision Award (ITVA) against all other NTVA Color Visionary of the year Gold winners from around the world.
- 5.2 ITVA is a competition where a panel of judges will evaluate each competitor's NTVA winning looks. The competitors will be judged based on the following:
  - 5.2.1 **80% of the total vote will come from the NTVA winning look:**
    - 5.2.1.1 70% on the color technique:
      - 5.2.1.1.1 Technique, application, color selection, commercial usability explanation
      - 5.2.1.1.2 Visible consideration of how color compliments the haircut (shape and length)
      - 5.2.1.1.3 Cut and color that complement each other while creating a beautiful, wearable, salon relevant look
      - 5.2.1.1.4 Finished color result
    - 5.2.1.2 30% on the overall vision & look:
      - 5.2.1.2.1 Total look (style, finish, makeup, clothes/fitting)
      - 5.2.1.2.2 Relevant individual vision/interpretation/creative personalization
      - 5.2.1.2.3 Professional finish
      - 5.2.1.2.4 Individual vision/creative personalization
  - 5.2.2 **10% of the total vote will come from the portfolio looks previously created and visible on Instagram**
    - 5.2.2.1 Craftmanship
    - 5.2.2.2 Beauty of the looks created
  - 5.2.3 **10% of the total vote will come from Instagram Activities:**
    - 5.2.3.1 Have an active channel by posting minimum 3 times a week
    - 5.2.3.2 Have more than 1,000 followers
- 5.3 The competitor who will receive the highest score as per article 5.2 will be declared the ITVA Color Visionary of the year and will be announced on social media in April-May 2025.

- 5.4 The ITVA Color Visionary of the year will receive:
- 5.4.1 The ITVA trophy
  - 5.4.2 An opportunity to experience an international shoot or event. (exact location and date to be announced at a later stage) (transport, accommodation, food & beverage and costs associated with this to be covered by Wella Professionals).
  - 5.4.3 All other expenses and costs, not expressly listed above, including, but not limited to, taxes, insurance, telephone charges, room service and laundry services, personal expenses, gratuities, entertainment, transfers, incidental charges, or any other items not specifically described in these official Terms and Conditions, any transportation not mentioned within such prize descriptions and all expenses for any of the foregoing are the sole responsibility of the ITVA Color Visionary of the year.
  - 5.4.4 No transfer, substitution or cash equivalent for any prizes will be permitted, except at the sole discretion of Wella Company due to prize unavailability for any reason, including but not limited to, cancellation, scheduling conflicts or an event of force majeure; and, in such circumstance, an alternate prize/prize component of equal value will be awarded and Wella Company's obligation to the winners will be fulfilled, and no other additional compensation will be provided. No responsibility or liability is assumed for damages, losses or injury resulting from acceptance or use of any prize.
  - 5.4.5 ITVA Color Visionary of the year must possess valid travel documents (i.e., valid photo ID, valid passport, VISA, etc.) to travel if needed. Failure to obtain required travel documents by ITVA Color Visionary of the year may result in forfeiture of prize.
